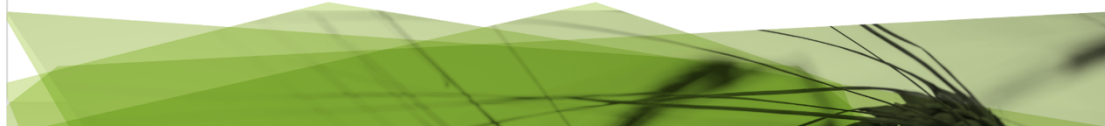
- All participants by default enter the meeting room muted.

This is one of the expected impacts of Nextfood envisioned in the proposal:

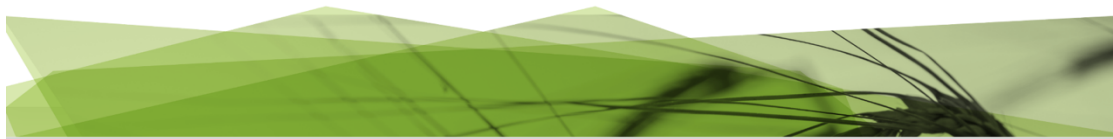

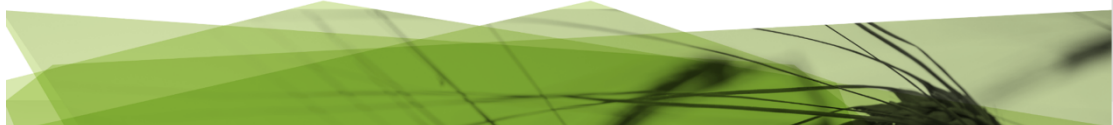
If Nextfood is going to have an impact on the educational sector, the Nextfood approach must become "something more" than just a project.

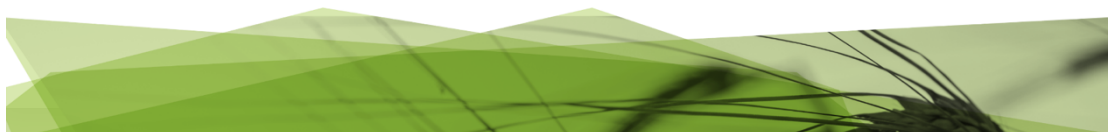

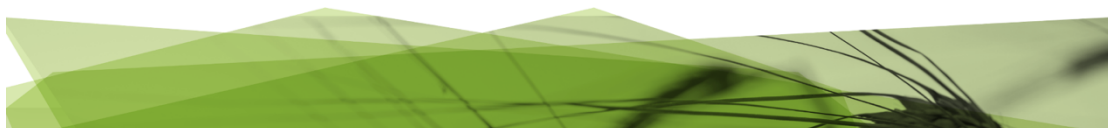
